Debt Refinance and Other Information	
1.	Copies of current promissory note and recorded mortgage for the debt being refinanced
2.	Transcript or equivalent showing that the borrower has been current on all payments for the debt being refinanced for at least one year OR from the date the loan was issued if the original note holder is providing the financing.
3.	Detailed breakdown of the original project costs (include copies of original settlement statement, sworn contractor's statement, construction estimates, equipment quotes, etc.)
4.	Documentation of equity injection (two months of account statements for the account(s) from which the funds will be withdrawn) if the appraised valued of the project assets is not sufficient to meet the equity requirement.
5.	Articles of Incorporation/Organization along with Bylaws and/or Operating Agreement for both Operating Company and Real Estate Holding Company. If either is a partnership then provide a Partnership Agreement.
6.	Real estate appraisal dated within six months of the application. Small Business Growth Corporation <u>and</u> the U.S. Small Business Administration should be named as a recipient on the report.
7	Application fee of \$1,000,00 payable to Small Rusiness Growth Corporation
